ENTRY ALLOWANCE: One male per vendor plus one extra male for every three females entered. Vendor may enter up to two animals per show class.

TAGGING: All sheep must be electronically identified. Animals which are not correctly tagged according to the current legislation will not be permitted into the market.

MOVEMENT: All sheep must be accompanied by ARAMS1 form, which is obtainable from your Local Trading Standards office. Animals which arrive without form ARAMS1 will not be permitted into the market.

WARRANTY OF SOUNDNESS: All sheep will be presumed to carry a Warranty of Soundness in respect of mouth, testicles and udder, such Warranty being expressly given and declared by each Vendor upon signature of the entry form.

BREEDING EWES: All ewes over two years old must be warranted as having bred a lamb or lambs.

CONDITIONS OF SALE: All registered sheep will be offered for sale subject to the Conditions of Sale for Sheep recommended by the Association of British Livestock Auctioneers.

DECLARATION : I hereby certify that the particulars given by me on this Entry Form are correct to the best of my knowledge and belief. I warrant all my entries to be sound in mouth, udder and testicles.
